We are Delighted to Present to You The First Annual Report of Welcome House.

In this strangest of years, since May 2020 Welcome House has:

registered as a charity; secured start-up funding and a building in the centre of the city; appointed a manager who has lived experience of being a refugee; established a strong cohort of volunteers who deliver a range of services in support of refugees and asylum seekers from more than 30 countries; commenced a programme of activities including a clothes store, run by our valued partner, Hull Help for Refugees; free Wifi; English language classes: art and music groups; groups for single women and single parents; a family support group; and agreed a service level agreement with Hull City Council, who have kindly provided us with our building, to hold us to account and evidence the difference that we are making to refugees and asylum seekers who come to our city to start their new lives free of fear and persecution.

In addition, we have reached agreement with a number of agencies to deliver services from our building, including the DWP, Citizens Advice, the NHS and the City Council. We continue to explore ways to deliver advice and support for asylum seekers and refugees. Our facilities include interview rooms, free internet connections and translators. We also offer our building at no cost to any group, organisation or individual who share our commitment to supporting refugees and asylumseekers. All our services are provided free of charge.

During stringent Covid restrictions we used a doorstep delivery system to reach dispersed refugee and asylum seekers across the City; delivering support in various forms, including food, clothing, transport, mobile phone support, personal support and events. We made over 200 doorstep deliveries and visits over this period. We also delivered our first grant funded programme, Walks for All, funded by Sports Humber, on time, on target and within budget. We have benefitted from funding for short term projects that enabled us to employ temporary positions for Jill Barton and Mel Jassim and their contribution at the start of our journey has been invaluable and we thank them for their commitment in strengthening our administration, direct refugee support activities and to help launch our volunteer programme.

Importantly, we have developed a vision to guide our development in response to what people using our services tell us that they want:

Welcome House aspires to see refugees and asylum seekers empowered to build and lead fulfilling lives, connected to local services, integrated with local communities and actively contributing to society in the Hull & East Yorkshire area.

Above all we will deliver with compassion, using our hearts as well as our minds when working with our beneficiaries; seeing people as individuals with all their strengths, experience, resilience and spirit, not defined by their migration status; understanding that each individual is unique, and that no process nor principle can replace compassion, respect and humanity.

In our founding months, we benefitted enormously from the experience and contribution of Leonne Griggs, Adrian Fisher, Andrew Palfreman and Dr Nigar Mahmoud. We have strengthened our governance with the appointment of two trustees who have lived experience of being refugees and developed our operational policies and procedures with the support of the HEY SMILE Foundation.

There is still so much to be done, especially in developing our community kitchen and café to be a place of companionship and sharing – a place which refugees and asylum seekers can make their own. We will establish a service users committee to continue developing the services and activities provided by Welcome House; and alongside that, an open forum, with invited speakers, to inform and discuss current topics of local and national concern.

None of what we have achieved in the last 12 months has been possible without the generous support and hard work of our volunteers, our partners, our funders and our trustees and we thank them all for their confidence in, and their commitment to, Welcome House.

A Snapshot of Our Impact in 2021

We've done a lot in our first year, here are some of our highlights and work we are proud of!



FROMMOHAMMED

Mohammed: originally from Syria whom Welcome House paid for his IELTS exam and assisted in his application for a Sanctuary Scholarship:

"The moment I got my leave to remain, I started applying for graduate scheme jobs which will start after my graduation. Recently, I got an offer for a full-time permanent job as a mechanical engineer from the Mott Macdonald company in Reading.

I want to take this opportunity to thank you so much for helping me. I very much appreciate your time and efforts. It means more than I can say."

NOT EVERYONE IS WELCOMING...

Ayub, Sara and their 3 children were assigned a house in Hull in late 2020. They had a hard time: "get back home", "you're not wanted here"; Ayub was assaulted and mugged; and the children hassled if they ventured out. They didn't know how to get help, and language was a problem.

By the time Mel, a Welcome House support worker, contacted them in February 2021, they were completely isolated and afraid to go out. We delivered food parcels, and topped up their mobile phone. One of our volunteers, who lives locally, provided immediate practical help, a link to local people, shops and services. Mel translated for Sara with GP and antenatal appointments, and with the children's schools.

Meanwhile, we had contacted our Police Liaison Officer and local Councillors, and involved the Anti Social Behaviour Team. Much of the problem was coming from two sources: a group of teenagers targeting the family, and regular abuse from a group of drinkers. It was soon stopped.

After 4 months of intensive support, Hull was beginning to feel like a new home.

"I came to the UK from Albania 7 years ago, during my time here I have struggled with my self confidence, feeling shy and struggling to speak to people, making life for me and my 12 year old son quite hard. After speaking with people from Welcome House last year they encouraged me to volunteer with them to help build my confidence.

After speaking with them for a while they convinced me that it would be a good challenge for myself as it would allow me to see that I am capable of doing many things which would help me overcome my anxiety and stress.

Welcome House worked closely with me, giving me full support and helping me to gain confidence in myself. Managers and colleagues were always calm and supportive, helping me to increase my confidence step by step. By trusting me to conduct important tasks by myself and keeping me involved with important aspects of the organisation made me feel respected and helped me to achieve my goals of challenging myself, improving my anxiety and to become less stressed.

I am really grateful for the opportunities given to me by the amazing team at Welcome House, the way that the team have accepted and trusted me has really helped me become more confident and has even led me to being

able to reduce my anxiety counselling sessions for the first time in the 7 years I have been receiving them."



Our Treasurer's Report

The generosity of our funders and donors in our first year has been tremendous. Welcome House has had a wonderful reception, attracting substantial donations and grants throughout the Year. That is the more remarkable since, although we started supporting asylum seekers and refugees right from the beginning, in August 2001 we had little tangible to show for it: no base, no centre of operations for most of the year. It was a real act of faith on the part of our donors to support a new start up so generously when we had no established record; and we are immensely grateful.

The Breslaff Centre provided our initial start up capital of £40,000 in July. On the strength of that we appointed Bashir Siraj, our General Manager, and he started operations immediately, developing relations with other agencies and supporting asylum seekers from the off. Further grants of £10,000 each were received from the National Lottery Community Fund and The Two Ridings Foundation in the Autumn, specifically for Covid relief work during the pandemic. Covid restrictions meant we had to develop home visits as a way of delivering services to refugees and asylum seekers; and these two grants enabled us to employ two part time workers to do so. The Sir James Reckitt Charity gave us another £10,000 in November.

Those grants gave us a solid financial base, enabling us to deliver the services promised for our service users, and to carry forward a reserve at the end of the financial year to be able to continue providing services. In addition, we received further grants, for specific purposes, from Active Humber (to fund a programme of walks for asylum seekers); from ACTS 235 (to make small cash grants to service users); and from Michael Ryan, for single women refugees, and refugee families. At the end of the year we received a grant of £15,000 from the Leader of Hull City Council, Steve Brady, from the Leader's Fund ; and a grant of £5,000 from The Leonard Chamberlain Trust.

That reserve, carried forward, has enabled us, in the current year, to equip and furnish our building, itself provided by Hull City Council on a peppercorn rent; and to install a kitchen and servery area, putting a social welcome into Welcome House. We will shortly have our own café, open 5 days a week; and over the year will develop a community meals programme for our service users. We have also substantially equipped our training rooms. We have had to develop our financial policies and accounting systems very quickly, as we went along. Preparing these first Annual Accounts has itself been a learning experience, but we have developed an excellent book keeping team, from our volunteers, who were complimented by our accountants for their records. Many thanks to all those who have helped.

On a personal note, can I apologise to all our funders and donors for not keeping them better informed of our progress during the year. I am conscious we have taken the money and have not always even acknowledged it! I can only plead that we have been really busy, establishing the charity, and all its policies and ways of working, focussing on our service users and delivering to them; and sometimes saying thank you has got overlooked. I hope we can do better this year: at least in developing the website and perhaps a Newsletter as a way of keeping in touch.

For the period from 7th May 2020 to 31st July 2021

1. ACCOUNTING POLICIES

- a. The charity constitutes a public benefit entity as defined by FRS 102. The accounts have been prepared on the accruals basis, in accordance with applicable accounting standards, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published on 16 July 2014 (as amended by Update Bulletin 1 published on 2 February 2016) and the Financial Reporting Standard applicable in the UK and Republic of Ireland, FRS 102), subject to any limitations due to lack of historical information.
- b. The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.
